## Location

The property is located in Wellington, Telford and is prominently positioned on the ring road at the junction of Bridge Road and Queen Street opposite the Morrison's Supermarket.

The property is situated in an established commercial / residential area approximately 100 yards from the local High Street. Local occupiers include Lidl, Dunelm, Wilkinsons and Morrisons.

There are excellent road links offering easy access to Telford Town Centre which is approximately 5 miles away. Nearby are Junctions 6 & 7 of the M54 motorway.

# **Description**

The property comprises of 3 commercial premises totalling approximately 9,049 sq ft.

The main building consists of a two-storey building which incorporates a 'Just For Pets' store on the ground floor with ancillary offices and stores. The first floor comprises vacant offices with a separate ground floor entrance. There is also a detached warehouse together with a single storey workshop to the rear which is occupied separately.

There is a double frontage on to both Bridge Road and Queen Street, with the rear unit fronting Queen Street.
